If any anomaly is found in the marks/score or other information entered by the applicant online with that of the original documents during the time of admission, the application of such candidates will be rejected and the Admission Booking Amount paid online will be forfeited.
- The selected candidates are advised to deposit the provisional fees for Internal of Rs. 7215/- after verifying the total score reflected against his/her name. Please note that this provisional admission will be categorically treated as cancelled at the time of confirmation of admission and the deposited provisional fees will be forfeited, if the information particularly marks entered during the filling up of Application Form do not tally with the actual marks reflected on the original mark sheets.
